

## BIOS - THE SENTRY - PRESS CONFERENCE - MONDAY, SEPT. 12, 2016

**Don Cheadle** is a founding board member of Not On Our Watch and a Goodwill Ambassador of the United Nations Environment Program. He has been traveling to Africa for the last dozen years, and co-authored two books with John Prendergast focusing on activism for peace and human rights. He has testified in Congress about African issues, written numerous op-eds, and met with officials from the UN and governments around the world about policy issues.

**George Clooney** is a co-founder of The Sentry and a founding board member of Not On Our Watch. He has traveled frequently to Africa over the past decade. He has testified in Congress about African issues, presented to the UN Security Council, written numerous op-eds, and met with officials from the UN and governments around the world about policy issues. He also co-founded the Satellite Sentinel Project, which used satellite imagery to monitor human rights hot spots in Sudan, South Sudan and the surrounding region.

**John Prendergast** is the Founding Director of the Enough Project and the co-founder of The Sentry. John has worked on African issues for over thirty years, including for the Clinton White House, the State Department, two members of Congress, the National Intelligence Council, UNICEF, Human Rights Watch, the International Crisis Group, and the U.S. Institute of Peace. He is the author or co-author of ten books.

**J.R. Mailey** is a Senior Policy Analyst for Illicit Finance & Conflict at the Enough Project and a Senior Analyst at The Sentry. He was the lead author on The Sentry's first investigative report, "War Crimes Shouldn't Pay." Prior to joining Enough, J.R. was a Research Associate at the Africa Center for Strategic Studies, where he specialized in natural resources, corruption and security in Africa. While at the Africa Center, he authored the ACSS Special Report, "The Anatomy of the Resource Curse: Predatory Investment in Africa's Extractive Industries." He also previously worked as a researcher for the U.S.-China Economic & Security Review Commission.

**Debra LaPrevotte** joined the Sentry Team after a 20-year career with the Federal Bureau of Investigation (FBI). Debra retired as a Supervisory Special Agent on the International Corruption Unit and was one of the FBI's experts in International money laundering and asset recovery. Debra initiated the FBI's Kleptocracy Program and seized more than \$1 billion dollars in corruption proceeds. Debra is also a forensic scientist and previously worked at the FBI Laboratory Division.

**Brian Adeba** is Associate Director of Policy at the Enough Project, where he focuses on the Sudans and the Horn of Africa. He was previously an Associate of the Security Governance Group, a think-tank in Canada that focuses on security sector reform in fragile countries. He supervised the coverage of the conflict zones of Darfur, Southern Kordofan, Blue Nile and Eastern Sudan for the Boston-based Education Development Center's Sudan Radio Service project in Nairobi, Kenya. Prior to this, he served as a project and publications coordinator at the think-tank, The Centre for International Governance Innovation in Waterloo, Canada.

**Brad Brooks-Rubin** serves as the Policy Director for the Enough Project and The Sentry. From 2009-2013, Brad served as the Special Adviser for Conflict Diamonds at the United States Department of State. Prior to joining State, Brad served as an Attorney-Adviser in the Treasury Department's Office of the Chief Counsel (Foreign Assets Control), where he provided advice on a range of economic sanctions issues related to, among others, Sudan, Democratic Republic of the Congo, and counter-terrorism. Brad has also held several positions in the private sector focused on trade compliance and responsible business.

**Greg Hittelman** is Director of Communications at the Enough Project and The Sentry, leading all media relations and communications programs. Previously, he ran communications for Conflict Awareness Project, an investigative group focusing on arms trafficking and transnational criminal operations.
