



Pfupiso: Dandemutande Remabhizimisi E-CIO

Chikamu chemapurisa anoita zvekuferrefeta cheZimbabwe's Central Intelligence Organisation (CIO) chinogona kunge chiine mukoto wacho unochiwanisa mari, Sangano reThe Sentry rakaona kudaro. Mashoko anogona kungoonekwa neveruzhinji anoratidza kuti chikamu ichi cheCIO chinodzora kambani yeTerrestrial Holdings, inova imwe yemakambani anoita zvekurimwa kwembanje, zvekugadzirwa kwemagetsi pachishandiswa simba rezuva, kuchera marasha, zvekushanyirwa kwenzvimbo dzinoyevedza, uye zvemutambo wegofu.

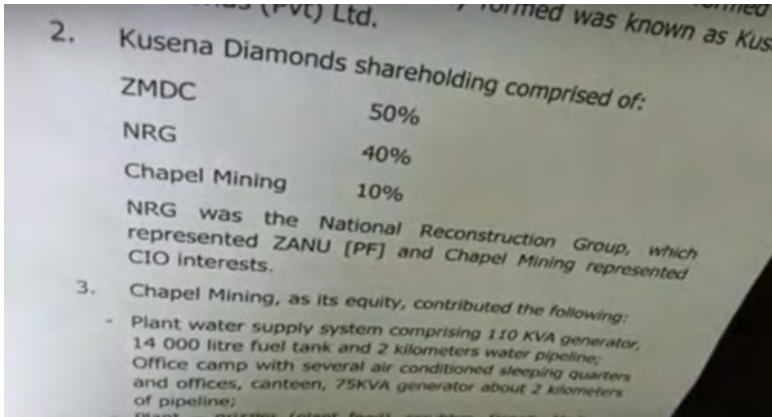
Pasinei nekuti mari zhinji dzeCIO dzinobva kubhajeti yenyika, chikamu ichi—chine bazi racho rezvebhizimisi—changezve chichizivikanwa nekuita mabasa ebhizimisi asiri echikamu chehurumende kuti chizivikanise imwewo mari yekubhadhara zvimwewo zvinenge zvisiri mubhajeti yacho.¹ Munguva yakapfuura, makambani emubatanidzwa eCIO aiita mabasa akasiyana-siyana akadai sekurima howa, kutengesana vana venzou kunze kwenyika, nekuchera ngoda.

Kuratidza dandemutande remabhizimisi acho

Sangano reThe Sentry rakakwanisa kupa mhedziso yekuti veCIO vanogona kunge vachitungamirira makambani anoti Terrestrial Holdings uye Terrestrial Mining nekuongorora mashoko anoratidza dandemutande rekare remibatanidzwa yemakambani eCIO.



Mugore ra2018, aimbove mukuru-mukuru weCIO General Happyton Bonyongwe akapa humbowo kukomiti yeparamende yeParliamentary Portfolio Committee nezvekambani inonzi Kusena Diamonds, iyo ve-CIO vari varidzi vechimwe chikamu chayo.^{2, 3, 4, 5} Paakasiya manotsi ezvaaitaura paikwanisa kutorwa mifananidzo nemakamera, Bonyongwe akabuditsazve pachena, asina kuzvironga, zita rekambani iyi, ine masheya anosvika 10% ekambani yeKusena inonzi: Chapel Mining.

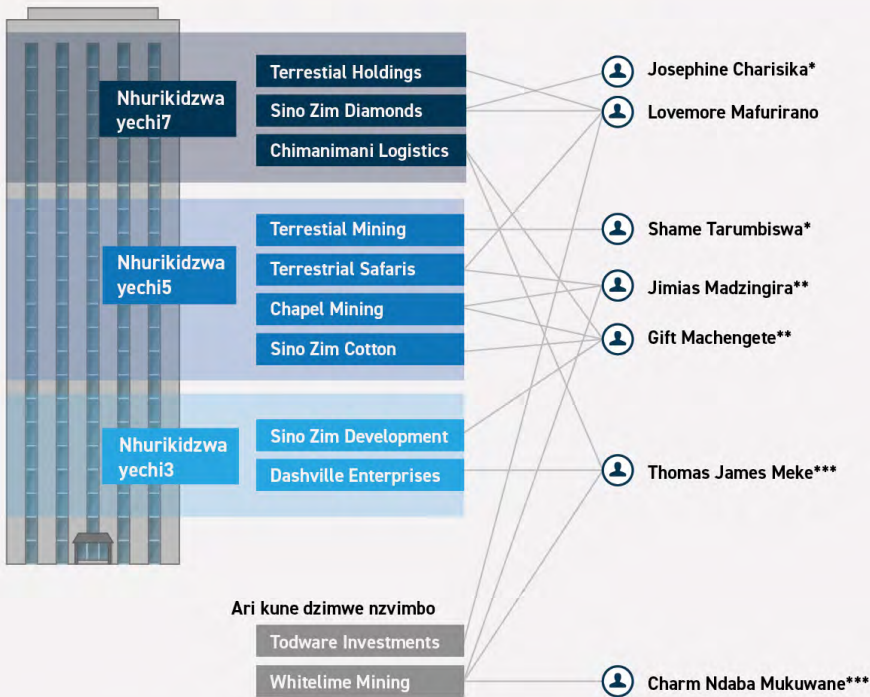
Sangano reThe Sentry rakaongorora zvinyorwa zvemakambani ose ari maviri yeKusena uye yeChapel Mining, pamwe chete nemundandanda wemishandirapamwe yekare yakaitwa neCIO namuzvinabhizimisi wekuChina nekuAngola anonzi Sam Pa. Zvinyorwa zvakafayerwa izvi zvakaratidza mundandanda wemazita emadhayirekita ekambani. Nekuenzanisa mazita emadhayirekita aya nezvinyorwa zvekumatare, zvinyorwa zvekare, nezvimwewo,

takaona kuti kazhinji zvaitwa nemapoka evanhu vanoita zvemari vari muzvikamu zvehutungamiri hweCIO uye nemapazi ezvemari nemafambisirwo ebasa. Takabva taona makambani aripo izvezvi ane madhayirekita akafanana neaimbova mumakambani aitungamirirwa neCIO kare uye aishandira ari pachivakwa chemahofisi chakafanana muHarare: cheLivingstone House.

Kutaura zvazviri, sangano reThe Sentry rakawana mashoko eku-ti makambani anoti Terrestrial Mining uye Terrestrial Holdings, anowanikwa munhurikidzwa yechishanu neyechisere yechivakwa cheLivingstone House, anoita seanotungamirirwa neCIO. Kambani yeTerrestrial Mining neimwe yayo, yeWhitelime Mining, yakapihwa nzvimbo huru yekuchera marasha inosvika mahekita 50,000 pedyo neLake Kariba iri kumadokero kweZimbabwe, inova nzvimbo iri pedyo nemafekitari mahombe ari kurongwa kuitwa uye atoripo ayo anoshandisa simba remarasha.^{6, 7, 8, 9, 10} Nechekunop-era kwegore ra2023, kambani yeTerrestrial Holdings yakaparura webhusaiti yayo, ichizvitsanangura sekambani iri pasi pekambani hombe iyo ine zvinangwa mumabasa ekuchera goridhe, marasha, nelithium; kurima mbanje, kutengesa zvivakwa; zvekufambiswa kwemashoko; zvesimba remagetsi anobva kuzuva nesimba remo-to; zvekutakurwa kwezvinhu nekuitwa kwehurongwa hwazvo; uye mabasa ekutakura vashanyi nemota munzvimbo dzinochengetwa mhuka.¹¹ Pavakabvunzwa nesangano reThe Sentry, kambani ye-Terrestrial Holdings yakaramba kuti veCIO ndivo varidzi vayo asi ndokuramba kudura mazita evane masheya mairi.

Makambani anoshandizana neCIO Ari paLivingstone House

Kambani yeTerrestrial Holdings panguva ino inowanika munhurikidzwa yechinomwe yechivakwa cheLivingstone House, icho munguva zhinji chaishandiswa nemakambani ane madhayirekita ari muchikamu chemaCIO.



Zviri mugirafu zvakarurama kana pachitariswa mashoko ari muchinyorwa chekambani chekupedzisira. Kudyidzana nevekuCIO kwakaonekwa: *kubva mubhuku rinowanika makero evekuCIO remumakore ekuma2000;

kubva muzvziviso zviri pamutemo zvenyaya dzemuZimbabwe; *pakumhan'arwa kwakaitwa nyaya yekubudiswa kwemashoko zviri kunze kwemutemo kunonziwo "Mediagate."

Kuvapo kwedandemutande remabhizinisi anotungamirirwa ne-CIO inyaya hombe nekuti chikamu ichi—icho chinonzi chine

zvachakaita pakutyisidzira vanhu munguva dzesarudzo—chinoda kutungamirirwa pachitevedzwa zvido zveruzhinji, kusanganisira kuongorora mafambisirwo emari uye nekuona kana chiri kushanda nenzira yejekerere, kuitira kuti vanhu vasambunyikidzwe.^{12, 13, 14} Kana vari muchikamu chekuchengetedzwa kwenyika vakava nekumwewo kwavanozwiwanira mari yavo zvinogona kukonzera kuti vapengereke zviru nyore.¹⁵
