Sangano reForever Associates Zimbabwe

Sangano reForever Associates Zimbabwe (FAZ), iro rakavapo nechinangwa chekubatsira ZANU-PF kuti ikunde musarudzo dza2023, rakaumbwa neshamwari uye nhengo dzemhuri yaAsher Walter Tapfumaneyi, uyo anowa mutevedzeri wadhayirekita wechikamu chemapurisa anoita zvekuferefeta cheCentral Intelligence Organization (CIO).

Mabasa eFAZ— ayo anosanganisira nhimbe huru yekukokorodza vanhu kuti vanovhota—anogona kunge akabatsira bato riri kutonga kuti rikunde musarudzo. Vaongorori, avo vanosanganisira vaongorori vemaitirwo esarudzo vesangano reSouthern African Development Community (SADC), vakazivisa kuti FAZ yaiwanika panzvimbo dzekuvhotera dzinosvika zviuru nezviuru, zvichitiwo kudyidzana kwesangano iri nebato reZANU-PF uye nevari muchikamu chinoona nezvekuchengetedzwa kwenyika kunogona kunge kwakaita kuti vavhoti vekumaruva vanzwe vatyisidzirwa.^{1,2,3}

Tapfumaneyi nesangano reFAZ vese vanopokana nepfungwa iyi yekuti veCIO ndivo vanotungamirira sangano iri.^{4,5} Zvisinei, zviri kuitwa nesangano iri pakubatsira FAZ zvinobatsira pakusimbisira mashoko ari kubuda munhau dzemuZimbabwe ekudyidzana kuripo pakati pemukuru wechikamu chekuferefeta ichi nesangano iri. Mumwe akapiwa masimba ekuona mafambisirwo ebasa musangano iri ishamwari yemhuri uyo akapa kero yepaanogara ya-



kafanana neyehengo yemhuri yaTapfumaneyi.⁶ Wechipiri wacho mumwe munhu ane zita risina kujairika achiita semushandi wehurumende anobatsira mumwe wevatevedzeri vaviri vemadhayirekita eCIO—chinova chinzvimbo chebasa chaTapfumaneyi—zvichimutsa mubvunzo kana asingori munhu mumwe cheteyo.^{7, 8, 9, 10, 11} Mwanakomana waTapfumaneyi ndiye akanyoreswa seakavamba sangano reFAZ pawebhusaiti yesangano iri, ukuwo mukadzi waTapfumaneyi ndiyewo ari kunzi ari kutungamirira rimwewo bazu remunzvimbo reFAZ.^{12, 13}

Mumwe akapihwa masimba ekuona mafambisirwo ebasa musangano iri ndiTangisai Tapera, uyo aiva wechipiri kuna Tapfumaneyi

pabasa panguva yaaiva gurukota renyika panhau dzine chokuita nemutungamiriri wenyika reMinistry of State for Presidential Affairs (MSPA), rinova bazi diki rakaumbwa mumakore a2009 kusvika ku2013 nechinangwa chekutsigira Mugabe uyo aiva Mutungamiri weNyika panguva yehurumende yemubatanidzwa.^{14, 15 16, 17, 18, 19, 20, 21}

Mukuwirirana nemashoko akataurwa nemumwe ari muchikamu chekuchengetedzwa kwenyika, bazu reMSPA rakaumbwa nechinangwa chekuita mabasa akasiyana-siyana nenzira isinga-onekwi nevanoda kuonesesa.²² Somuenzaniso, zvichitevera nhau ine chokuita nengoda iyo yakatekeshera nechekumabvazuva kwenyika yeZimbabwe makore ekuma 2000 ava kunopera, Tapfumaneyi, Tapera, negweta rinonzi Gerald Mlotshwa vakaumba makambani ,maviri anoti—Moosejaw Enterprises uye Rosy Red Capital.^{23, 24, 25, 26} Pava paya, Tapfumaneyi, Mlotshwa, naTapera vakaumbazve mamwe makambani maviri sechikamu chekuteng-esserana mafuta pakati pebazu reMSPA nyenika yelran anoti: Lionshow Trading muZimbabwe uye yeLionshow Resources muUnited Arab Emirates.^{27, 28, 29}

Paakabvunzwa zvine chokuita nebasa rake kusangano reFAZ kana kuti ari kuMSPA, Tapera akati aisava nerusununguko rwekukurukura chero mashoko.³⁰ Mlotshwa akatsanangura kuti aingopa mazano pane zvemutemo uye aisashandidzana pane zvebhizimisi naTapfumaneyi, uye akati pamutemo aisungirwa kusakurukura zvakawanda nezvazvo.

FAZ yakabvuma kuti sangano iri rakatanga kuumbwa nerutsigiro reMSPA asi yakazoti sangano iri rakazosimbaradzwa nevazvipiri avo vaiva nechido chekutsvagira rutsigiro musarudzo bato reZANU-PF. Tapfumaneyi nesangano reFAZ vakaramba pfungwa yekuti veCIO vakabatsira pakuumba sangano iri rinoshandidzana nebato



reZANU-PF. Sangano reFAZ rakaramba kudoma vanoritsigira nemari, richipa mashoko ekuti rinopiwa mari “nevazvipiri avo vasingadi kuzivikanwa.”³¹

Kachiratidzo kadiki kanopa pfungwa yekubatanidzwa kwevari muchikamu cheCIO kari pamashoko anogona kuwanikwa neveruzhinji ekuti: Nhamba dzinonyanya kushandiswa nesangano reFAZ dzaimboshandiswa nemumwe wevaiva pazvidanho zviripakati nepakati zvemapurisa ari muchikamu cheCIO, mukuwirirana neongororo yemazita akasevhiwa mumaapu efoninochengeta mazitanenhamba dzefono dzevanoashandisa.^{32, 33} Mukuwedzera, kuvapo kwevazhinji vanokurukura parunhare naTapfumaneyi avo vakapiwa masimba ekuona mafambisirwo ebasa musangano iri kana kuti vakarivamba kunoratidza kubatana kuripo, kana kusiri kutipakati pechikamu cheCIO nesangano reFAZ, zvinenge zvichigona kureva kudyidzana kuripo pakati paTapfumaneyi nesangano reFAZ.

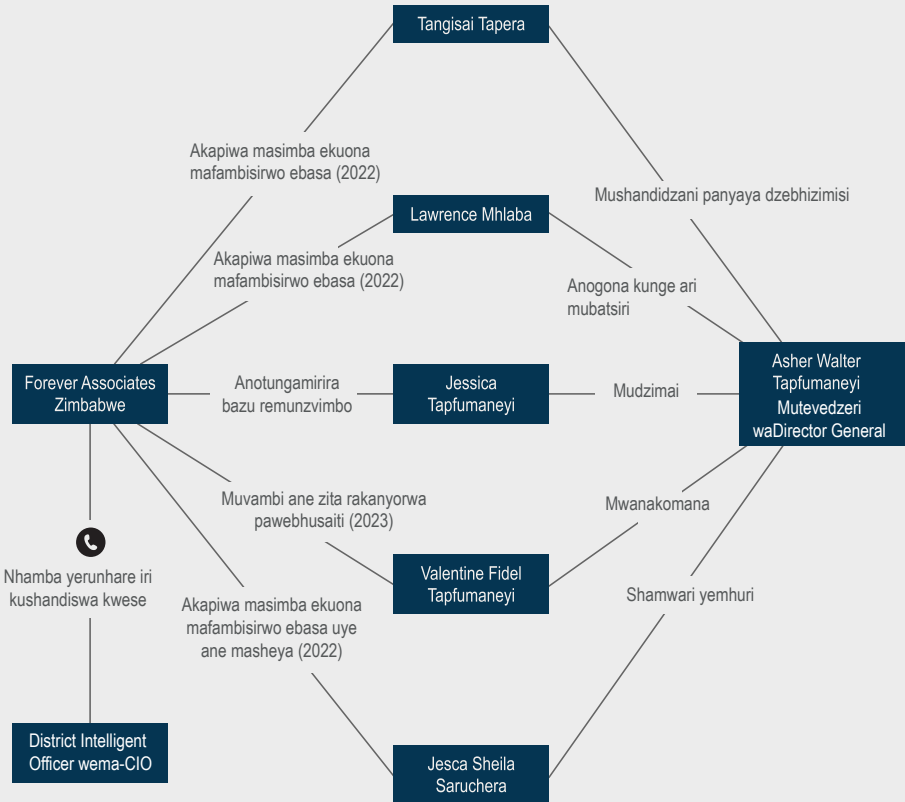


Kudyidzana Kuripo Pakati paAsher Walter Tapfumaneyi nesangano reFAZ
